PLEASE NOTE: Each juried membership fee covers the jurying, administrative costs, and one year of League Membership. For accepted applicants, you become a State Juried Member and must pay an \$85 annual fee after the first year of membership. Local Juried (single-council) must pay an annual fee of \$55 for individual, \$65 for partnerships. For deferred applicants, you become a Supporting League Member for one year. Deferred applicants are also allowed to re-submit to the jurying process for no additional fee. Supporting Members also receive discounts at the League's fine craft galleries and other venues where noted.
